(Revenue \$) Operation School Bell provides new clothing and shoes to kindergarten thru high school students who have been referred by Montgomery County school counselors. In addition this program also provides clothing as needed to children in Montgomery County emergency shelters. It also provides elementary children and schools with book donations and in-school Dr Seuss reading opportunities. This year 10042 students were served.

4b (Code:) (Expenses \$ 114511. including grants of \$) (Revenue \$) Scholarship provides scholarships for various types of continuing education. Recipients include high school graduates attending a 4 year college or university adults needing to return to education to better their quality of life adults needing certification courses to obtain employment and mentally or physically challenged individuals for therapeutic programs. Twenty high school graduates received scholarships for their first year at a 4 year college one student received a scholarship to attend community college 6 received Continuation Scholarships 28 received Certification Scholarships and 10 received Nontraditional Scholarships. Scholarship funds provided equine therapy treatment to 252 individuals.

4c (Code:) (Expenses \$ 19466. including grants of \$ 11750.) (Revenue \$) Caring and Sharing provides for basic needs of the homeless residents in need and others in transition in Montgomery County. This program provides thrift shop vouchers and Welcome Home baskets to families referred by Family Promise of Montgomery County. Welcome Home trunks containing bedding and personal care items are provided to young adults aging out of foster care and entering into transitional living programs. Basic clothing is provided for children and adults through several community service agencies. Healthy snacks are given to several schools for at risk children. Monthly birthday parties are provided for residents at a local nursing home. During the year 18083 people have been helped.
